Total number of starters NOC Rank 4-10 corrected to 28 instead of 30 (former calculation mistake). Total number of starters updated accordingly (from 94 to 92). D. Introduction of "OWG NOC Quota List" for NOC quota allocation places, which will be made up by the best 12 single results (Nations Cup points system, WC and WCH competition results) of the 2020/21 and 2021/22 season. FIL	Luge Overall: The Olympic Qualification World Ranking List (General Class) accumulated points from the pre-Olympic Season and from the Olympic Session has been removed from the lists used for the qualification system. The period to achieve points for Pre-Olympic Season and Olympic Season World Cup Ranking List (General Class) have been adjusted. D.3.3 - Correction "If there are still remaining quota places that are not filled after applying D.3.1 and D.3.2." added "and D.3.2".
WCF	Curling Due to the cancellation of 2020 World Curling Championships for Men's, Women's and Mixed Doubles, necessary adjustments were made in D.1, D.2, E and G. Updated location of World Men's Curling Championships (in April 2021) from Ottawa to Calgary, CAN. Curling (Mixed Doubles) - Due to the cancellation of the 2020 World Mixed Doubles Qualifier (WMDQ2020) it has been replaced by an Olympic Qualification Event (OQE). The format will be made up of all teams who compete at the 2021 WMDCC but do not qualify for the Olympics - The host of the OQE will get a place in the Mixed Doubles OQE - The final three (3) places of the sixteen (16) team Mixed Doubles OQE event will be awarded to the top three (3) finishers in a new event call the Mixed Doubles pre-OQE. This mirrors the structure of the Men's and Women's pre-OQE. G. updated the dates and location of World Mixed Doubles Curling Championships and World Women's Curling Championship. G. Confirmation of location and updated dates for World Mixed Doubles Curling Championships.
IIHF	Ice Hockey Due to COVID 19 pandemic, the events dates of the Olympic Qualification Tournaments have been changed and necessary adjustments were made in D.2, D.4, E and G. The events dates of the remaining Women's Olympic Qualification Tournaments have been changed.
