



As a participant in the 2018 Olympic Winter Games PyeongChang 2018 (the "2018 Games"), I acknowledge and agree that my participation in the 2018 Games is conditional upon my acceptance of and my compliance with all the provisions of these Conditions of Participation and the rules referred to herein which have been determined by the International Olympic Committee (the "IOC" and the PyeongChang 2018 Organizing Committee for the Olympic and Paralympic Games ("PyeongChang 2018").

For participants who are athletes, when the form is signed in their country of residence at the time of signing this Conditions of Participation form their participation in the 2018 Games is further conditioned upon the participant's proper and legal/governed confirming their agreement with the content provided hereunder by the member participating through the signature of the Participant's Eligibility Accreditation Officer for Games for Men/Women.

- 1. Capture/Use of Images:** Participants may be filmed and photographed, during the 2018 Games.
 - A. Understanding that as a participant in the Olympic Games, participating in an exceptional event which brings international and national attention and in consideration of the occurrence of my participation therein, I agree to be filmed, take video photographs, recorded images, make speeches during the Olympic Games, and that any confidential information, may be used in any manner, format and through any media or technology whether now existing or created in the future by the IOC and third parties authorized by the IOC, during and after the Olympic Games in particular in relation to the celebration and promotion of the Olympic Games, the Olympic Movement and the IOC commercial or non-commercial activities.
 - B. The IOC, SOCOG and other rights holders/owners, and reasonable third parties, may use the above information and other information for promotional purposes, including by disclosing made information or promote betting related to the 2018 Games and other related activities.
 - C. The IOC Code of Ethics and in particular the Rules on the Prevention of the Manipulation of Competitions applies to the 2018 Games and that I will not participate in support, including by disclosing made information or promote betting related to the 2018 Games.
 - D. The IOC, SOCOG and other rights holders/owners, and reasonable third parties, may use the above information and other information for promotional purposes, including by disclosing made information or promote betting related to the 2018 Games.
- 2. Processing of personal information:** PyeongChang 2018, the IOC and Korea authorize the use of personal information to be processed for the purpose of the 2018 Games, message accreditation, competitions and results, carry out the anti-doping activities, prevent manipulation of competitions and provide services to participants and to the media.
 - A. 
